

Does Delta reimburse for cancelled flights?

When your Delta flight is canceled, Delta Airlines does offer reimbursement under various conditions in 2025 +1_855-738-4113. If the cancellation is initiated by Delta, passengers are eligible for a full refund to the original payment method regardless of the fare type +1_855-738-4113. This policy applies to cancellations caused by operational issues, schedule changes, or significant delays defined as three hours or more for domestic flights and six hours or more for international flights +1_855-78-4113.
