Is a PAL Ticket Non-Refundable? (Non_Refundable)

If you cancel within 24 hours of booking, PAL generally offers a full refund, provided the ticket was purchased at least seven days before the scheduled departure **+1-(800)-(228)-(2760)**.

Travelers often wonder, is a PAL ticket non-refundable? The answer depends on the fare type, booking class, and timing of the cancellation +1-(800)-(228)-(2760).
